## **PRESIDENT'S REPORT.**

I have pleasure in presenting the President's Report for 2018 the 106<sup>th</sup> Annual General Meeting.

I would like to start by thanking the Committee Members and our staff, Rob Prescott and Grant Pryor for their contribution and assistance during what has proved to be a productive year.

To our retiring member, Peter Volker, thank you for the time you have served on the Committee, and especially as Media Officer in previous seasons.

The Committee is there to administer the sport for the whole State and all its members, being clubs, schools rowing association and individuals.

It is important to remember this when some of the decisions made by the Committee may not necessarily fit individual circumstances or where your club or school is currently situated.

The following reports will outline our activities during the past season, congratulations to our winners of State Pennants, Championships and individual trophies for personal achievements. The most successful club for the season was TUBC who won both the State Pennant and the Hydro Cup and Friends' took out the School Pennant. Congratulations to both these clubs and their members on and off the water who contributed to their success.

To our National representatives, Georgia Nesbitt, Sarah Hawe, Ciona Wilson and Connor Ryan congratulations on your achievements.

To those that have represented our State at the Nationals and the Australian Masters Championships congratulations on achieving this status in your chosen sport.

The past season has seen two extra major events held at Lake Barrington. The Australian Masters Games were held in October which gave the opportunity for multiple water sports to be held on the lake. This resulted in a large number of participants being able to utilise our facilities for the first time. A small group of volunteers over the week were able to conduct a successful event which was also of a financial benefit to Rowing Tasmania.

The second event during the season was the Australian Masters Rowing Championships, held in May. This was our first chance since 2011 to conduct a major event, and once again our volunteers stepped up to assist in what was a marathon event. We once again showcased Lake Barrington International to the rowing community who took the opportunity in large numbers, to come to our state and participate. The event was a major success with glowing reports and once again, it gave Rowing Tasmania additional funds to be used for future projects, which will benefit all members.

To Rob Prescott a special thank you for his organising contributions and to all members of the sub-committee and volunteers, thank you for what was a very enjoyable week.

As you are aware Rowing Tasmania only operates as a successful organisation due to the large number of volunteer member that contribute at all levels. It is not possible to thank everybody in this report, but I would like to take the opportunity to mention some of these volunteers. To Kim Wilson, a very big thank you for her contribution to developing the Easy Oar Cafe and taking on the task of Catering Manager. Kim has retired from this position at the end of the season, after putting in a major effort at the Australian Masters Rowing Championships. To Chris Symons, who took on the Boat Park racking project? The comments from our own members and all the visitors during the season highlights the professional manner in which this project was approached. To the retiring President of the TSRA and delegate to Rowing Tasmania, I would like to thank Julian Joscelyne for his contributions to both organisations over the years. Julian has offered his time in the coming season to update our Constitution, which is tedious, time consuming project.

The Committee has approved funding during the year for the upgrade and improvement of our facilities at Lake Barrington. Our new caretaker, Steve May joined the team during the season and his dedication and skills are evident by the condition of the surrounding grounds at the course. To Steve and our cleaning staff, thank you very much for your hard work during the season, which has been very busy with the extra events.

We have continued the project of tree maintenance for the safety of our members and visitors to the area. This is an expensive project, but one which needs to continue, especially with the strong winds that LBI has been experiencing during the off season.

The last thousand metres of the buoyed course was replaced for the Australian Masters Rowing Championships and the first thousand metres will be completed by the coming season.

To all members, both on and off the water and volunteers of our clubs and schools, congratulations for your contribution to a successful season. Volunteerism has been on the decline across all sports, and rowing is no exception. I would ask all

members to consider volunteering for the positions that become vacant, both in your clubs and Rowing Tasmania. This season we have been operating on a smaller number of volunteers, especially in the area of finance, media and BOAT officials. The smaller the number of volunteers we have, the burn out rate for those filling the positions shortens. Please do not hesitate to put up your hand and join the team.

Thank you for your support for the 2017/2018. Let us make the next one bigger and better.

**Independent Auditor's Report  
To the Members of Rowing Tasmania Inc**

**Report on the Audit of the Financial Report**

We have audited the financial report, being a special purpose financial report of Rowing Tasmania Inc (the Association), which comprises the balance sheet as at 30 June 2018, the income and expenditure statements for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the statement on behalf of the committee.

**Opinion**

In our opinion:

- (a) the accompanying financial report presents fairly, in accordance with the accounting policies described in Note 1 to the financial statements, the financial position of Rowing Tasmania Inc as at 30 June 2018, and its financial performance for the year then ended;
- (b) we obtained the information we required for the audit and Rowing Tasmania Inc kept proper accounting records and other books during the year ended 30 June 2018; and
- (c) the rules relating to the administration of the funds of Rowing Tasmania Inc have been observed.

**Basis of Accounting**

Without modifying our opinion, we draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared for the purpose of fulfilling the committee's financial reporting responsibilities under the *Associations Incorporation Act (Tasmania) 1964* ("the Act"). As a result, the financial report may not be suitable for another purpose.

**Basis for Opinion**

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report. We are independent of the Association in accordance with the auditor independence requirements of the Act and the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 *Code of Ethics for Professional Accountants* (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

## **Responsibilities of the Committee for the Financial Report**

The committee of the Association are responsible for the preparation of the financial report that gives a true and fair view in accordance with the accounting policies described in Note 1 and the Act and for such internal control as the committee determine is necessary to enable the preparation of the financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the committee are responsible for assessing the Association's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the committee either intend to liquidate the Association or to cease operations, or have no realistic alternative but to do so.

## **Auditor's Responsibilities for the Audit of the Financial Report**

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.

As part of an audit in accordance with Australian Auditing Standards, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial report, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Association's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the committee.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Association's ability to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.

We communicate with the committee regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.



We also provide the committee with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

## **NOTES TO AND FORMING PART OF THE ACCOUNTS**

### **FOR THE YEAR ENDED**

#### **1. STATEMENT OF ACCOUNTING POLICIES**

These financial statements are a special purpose financial report prepared for use by members of the Association in order to satisfy the financial reporting requirements of the Associations Incorporation Act (Tas) 1964.

The committee has determined that the Association is not a reporting entity, therefore the financial statements are prepared on an accruals basis from the records of the Association only. They are based on historical cost and do not take into account changing money values or, except where specifically stated, current valuations of non-current assets. No regard has been paid to Accounting Standards and other professional reporting requirements (Urgent Issues Group Consensus Views) in the preparation and presentation of these financial statements.

#### **2. INCOME TAX**

The Association's income is exempt from income tax pursuant of Section 50-45 of the Income Tax Assessment Act 1997. All figures recorded in the Financial Statements are net of Goods & Services Tax (GST).

In November 2005, the Department of Tourism Parks Heritage and the Arts ("the Crown") gifted to Rowing Tasmania Inc by deed, various assets within the complex known as the outdoor pursuit Centre at Lake Barrington for nominal consideration of \$1. These assets include non-fixed assets kept in the pursuit center, rangers' cabin and facilities building together with the water infrastructure of the rowing course.

The committee has not assessed the fair value of these assets due to the difficulty in obtaining a reliable method of valuation. In the committee's opinion the fair value of this equipment on an alternative use basis would be minimal due to the specific nature of the equipment and the cost of dismantling and relocation. Accordingly, the fair value of these assets is not reflected in the Balance Sheet of the Association and the value of the gift from the Crown has not been included in the retained earnings of the Association

**5** GOVERNMENT GRANTS

The government grants received during the year are recorded on cash received basis.

**6** ADJUSTMENT 2017

The Debtors at 30/06/2017 were overstated which resulted in an overstated amount of Membership Fees received for the year ended 30/06/2017.

This has been adjusted to reflect the correct Membership Fees for both 2017 and 2018.

The club support of the rostering of other jobs – boat driving and numbers – has also become very efficient with volunteers coming forward at all times. This is a critical task and the regatta cannot proceed without this support. The assistance of Peter George in organising the boat driving roster is greatly appreciated.

The Regatta Management database – rp7 – continues to be an extremely efficient regatta organiser which enables all the paperwork to be achieved efficiently and quickly. Regatta manager has developed a basic regatta "score" for rating rowers, but it is still slightly short of the mark as it takes each race as self-standing. This fails to account of weather variations. I hope this can be addressed in the near future.

Finally, thanks again to the many hours provided by the on-water Boat Officials and Referees and to the many people giving time to help in the Office. The time provided by all the volunteers helps the Regattas run as smoothly as they do. A regatta would simply not happen without the support and generous offer of time from these people. In addition, as all our regattas are now managed by Rowing Manager and rp7, a number of other volunteers have up-skilled in the office so that they are available for other non-pennant regattas such as Schools regattas and Masters regattas.

The Pennant and Hydro Cup were closely fought, with three clubs being in the mix, with Tas Uni Boat Club getting across the line. The Schools Cup was always a clear result.

## **Executive Officer Report 2017-18**

This past 12 months has been a very busy and productive period for Rowing Tasmania with involvement in a number of project and events.

### **Australian Masters Games.**

In October of 2017 the Lake Barrington International Rowing Course played an important role in the Masters games with the site being the most utilised venue for the Games week. Of the total of 4000 Games Competitors our venue hosted just on 20 percent of the athletes who competed in flat water canoe, stand up paddle boards, out-rigger canoes, rally hill-climb and rowing. It was interesting to watch other paddle disciplines race and we also integrated the canoeists and SUP's with the two day regatta program, both sports enjoyed seeing how the other raced. I would like to thank and commended the organisers of the other sports for the way in which they presented their respective sports. Once again our volunteers stepped up and the compliments that were received on the way our venue was both presented and operated proved that we have the ability to host major events. To all involved thank you for your involvement and support.

### **Tasmanian Pathway Program.**

This exciting partnership between Rowing Australia, Rowing Tasmania and the Tasmanian Institute of Sport has seen in its first full year a solid base laid to give our athletes the opportunity to progress with in our sport to the highest levels. The three amigos, Grant Pryor, Brett Crow and Brendan Long are working with and looking at a broad group of athletes, starting with year eleven's and twelve's and then the club members. These athletes have been given specific training camps, coaching and those on scholarships access to the facilities of the TIS. The Pathway Team has worked with a number of schools during the year and I am sure we will see these relationships continue and be added to. I would like to make mention of the Tasmanian School Girl Pathway Eight crew who competed at the Schools Pathway Eights trials at SIRC, with their second place the crew became the best performed State women's crew and I would like to congratulate them on the way they trained and came together as a crew in a short period of time under the expert guidance of Neil Stump. The Pathway Partnership is led by Jaimie Fernandez from Rowing Australia and Paul Austen from the TIS and I would like to thank them both for their support.

### **Australian Masters Rowing Championships.**

To host two National events in the space of 12 months has certainly asked a lot of our volunteers and staff but this regatta was a fantastic event with 800 plus competitors racing on our Lake. The President's Report gives more details on this event and I would like to personally thank all involved in presenting a fantastic event plus a special thank you to the weather god's, while there was Armageddon all around us Lake Barrington was calm and peaceful in the eye of the storm.

### **Lake Barrington International Rowing Course.**

The Lake again has had a busy year with not only the two National events plus the normal regatta season and the accommodation side has also produced some very busy days and weeks. Traditionally January sees the hosting of a number of school camps and we had the pleasure of the Melbourne University Boat Club who had a ten day camp and with Aquinas College from Perth there were only a few free nights. There were two major projects completed with firstly the Boat Rack Replacement Project being finished prior to the Australian Masters Games. The funding for this has come from the Tasmanian Community Fund and I thank them for their ongoing support. The racks were designed, with military precision by Chris Symons and with Mick Goodger and Luke van Tienan worked with the volunteers from Kentish Rowing to remove the old racks and erect the new. The boat capacity has now gone from two hundred forty to in excess of four hundred and sixty boats and to see the racks full at our regattas is a pleasing sight. The second major project has been the re-buoys of the last one thousand metres of the course plus associated work on the course, thanks to Mick Goodger, George Homer and

their crew for not only this project, plus their efforts in preparing for the two National events. I would also like to say thank you to our staff at Lake Barrington firstly Steven May has joined us after 30 years at Tasmazia as our Groundsman. The property is looking fantastic and I commend and thank Steve for his enthusiasm and look forward to see how the property changes into the future. Lisa Marie Haywood and Cheryl Pike have both done a great job at the Lake and I thank them both for their involvement at efforts at their Lake. At the time of writing of this report Lisa has given birth to a son Archie, congratulations to both Lisa and Deon. I would like also to thank all from Parks and Wildlife for their ongoing involvement at Lake Barrington. Many of you will have noticed the dramatic improvement in communication from the Lake with the addition of a Telstra mini-cell mobile be erected, the free Wi-Fi from the Rowing Tasmania grid and the addition, through the State Growth Tasmania, of a free tourist Wi-Fi network. One of our talented volunteers, Fred Slamen has spent numerous hours working on not only the Wi-Fi network but many other electronic projects and I would like to thank him for all that he has done.

### **Strategic Plan 2017-2020.**

The Strategic Plan is reviewed at each meeting of the Rowing Tasmania Board and a number of the Strategies have been met in the Plan's first year, including establishing relationships with the Media, Tasmanian Pathway Program, a range of Governance programs to name a few. As this is an ongoing project regular updates will be published.

### **Media and Communications.**

Communication was identified in the planning process for the Strategic Plan as a critical task. The website is averaging one hundred thousand visits per year and is constantly being upgraded with more information so it will ideally be a one stop resource. Social media is also a growing component of the communication matrix with just under 4000 "likes" on the Facebook pages and with Instagram also showing solid growth. I would also like to thank the Club Secretaries and School Directors or Rowing for their efforts in dealing with the numerous emails that are sent.

### **Safety.**

During 2017 all Clubs and Schools were asked to respond to a proposal in regards to a change of lights on rowing shells at the initial request from Marine and Safety Tasmania (MaST). At the end of this consultation period and with the involvement of TasPorts, MaST have legislated the changes which will take effect from mid-2019. Details of the changes are on the website. In 2020 there will be a new standard for life jackets and as this is an important part of our coaches' kit I would urge you to firstly upgrade all jackets to the new standard and to make sure that all self-inflating jackets are serviced on an annual basis, further information is on the website.

### **Communities, Sport & Recreation.**

Rowing Tasmania has a strong relationship with the Department of Communities, Sport and Recreation and we have contact most weeks through our Project Coordinator who provides both advice and information on a range of topics including, funding and grants, governance, coach education, Tasmanian Sporting Hall of Fame to name a few. I would like to thank all at Communities Sport and Recreation for their support and involvement with Rowing Tasmania and our affiliated Clubs and Schools

Our sport is a very busy one and my reports presents only a snapshot of what is done throughout the year and I am sure that next year will be busier again. I would like to thank James Gibson and the Board for their ongoing support, my colleague Grant Pryor for both his work ethic and passion for the sport and those in it. To all those who volunteers from the Clubs, Schools or at Lake Barrington, thank you for your involvement, our sport couldn't be what it is today.

## **State Development and Pathway Officer Report 2018.**

### **State Pathway Program.**

The role of SDPO includes working with clubs & schools to bring students into club-based programs, assist with daily training environment, identify & prepare Tasmanian athlete rankings, assist development of athletes to progress to the Talent Squad & NTC Development Squad, plan & coordinate coaching seminars and oversee Coach Accreditation. In our second year, engagement from Schools & Clubs is now gaining stronger support. Invitations have been extended for RT Staff and/or Board members to attend Club/School meetings and camps to discuss any aspect of the program. Recent visitations from RA representatives provided great opportunities for Club Presidents to meet Chief Executive Officer, Ian Robson in an informal environment. Attendees were able to discuss any aspect of RA programs including Pathway. Well attended luncheons and forums were held in both Launceston & Hobart.

### **Talent Squad Selection**

SDPO prepares annual athlete ranking data for a minimum of 40 underage athletes and presents a recommendation list of the top 10 male & female athletes to the State Pathway Program partners for consideration of inclusion in the Talent Squad. Recommendations are based on outcomes from NTID testing, regular 30 min. ergometer monitoring (IPM), 2K ergometer test results and assessment of performance at Regattas, Time Trials and Camps.

### **National Underage Selection Trials**

Following the Australian Rowing Championships in March several young Tasmanians were invited to attend trials at SIRC for National Team selection later in the month.

In the U21 Lightweight Single Scull, Connor Ryan (North Esk) raced well in the final, finishing 3<sup>rd</sup> and earning his place in the Australian Team to contest the Trans-Tasman series. In the subsequent first leg of the series against New Zealand at SIRC in July, Connor again performed above expectations, both in his specified sculling events and as a substitute in the men's pair. Connor will travel to New Zealand in August with the Australian Team to



contest the final leg of the series, which Australia is leading narrowly.

In the Men's U23 Category, Alec Paterson (Buckingham) was our sole Tasmanian triallist and despite his best efforts in the Lightweight Double & Single, narrowly missed Australian selection. At the recent U23 World Championships, Alec's trials partner in the double, Sean Murphy, achieved a Bronze medal in the Lightweight Single Scull.

Lars Gillingham & Daniel Barratt (North Esk) trialled in Junior Men's Pair. Abbey Boutcher & Amy Bain (TUBC), Annaliese Mackie & Rebecca Bye (North Esk) and Jessica Stephens (DMCRC) trialled in Junior Women's Single Scull. All athletes gained valuable experience and acquitted themselves well. Rebecca Bye finished a creditable 5<sup>th</sup> in the A Final, whilst Lars Gillingham & Daniel Barrett also made their A Final, finishing in a creditable 8<sup>th</sup> placing.

The women joined Isabelle Higgins & Daisy Pilkington (Fahan), Eva Davis & Caitlin Hogan-Jones (DMCRC) to represent Tasmania in the Australian Interstate Schoolgirls' Pathway Eight. From a field of five in their heat, the Tasmanian girls were the surprise packet finishing second to a strong Queensland #1 crew, ahead of NSW, ACT & SA/WA composite crews.

In the final our Tasmanian girls improved on their heat time by some six seconds, again achieving second behind favorites Queensland #1, with Queensland #2 in third place, ahead of South Australia, New South Wales #1, Aust. Capital Territory, New South Wales #2, Western Australia and WA/SA Composite crew.

### **State Team and Pathway Performance Camps**

State Team Camp was conducted at Lake Barrington in January with 43 attendees.

Athletes whom were part of our 2017 State Team were extended invitations together with the top ranked underage athletes from the previous season.

In conjunction with our TIS Pathway Partners, we have conducted three successful Performance Camps to date this winter. In seeking to improve our national competition results next season, select invitations were extended not only to athletes from our 2018 Interstate Team, but also to athletes who have continued to demonstrate they have the desire, vision & commitment necessary to achieve high performance outcomes.

Some eighteen school leavers were also extended initial invitations.

Given 2019 is the Centenary of the King's Cup we are encouraging our senior athletes to participate in the Performance Camps and trust State Selectors might consider prioritising this boat.

We would like to extend our appreciation to those Clubs that loaned equipment and to coaches, chaperones and helpers whom availed their valuable time to make the camps successful.

### **Junior Pathway Camp**

Our camp for eligible U19s was conducted during Term 3 holiday break, October 7<sup>th</sup> – 8<sup>th</sup> at Lake Barrington. The camp was an open invitation basis, however, numbers were limited logistically to approximately fifty athletes + coxswains & coaches. Because of the positive response we ended up catering for 57 junior rowers & coxswains, 7 coaches & 5 support staff.

The camp was an initiative to encourage more of our top U19 School Rowers whom have demonstrated their potential during the past rowing season via Regatta performances, Talent Identification and Individual Performance Monitoring, to consider high performance rowing pathways, including the Interstate School Pathway Eights event.

Rowers trained with their peers, were exposed to a range of other coaches and generally gained better understanding of the further rowing opportunities available to them.

### **Coach Education**

Rowing Australia Level 1 Coach Accreditation is now available on-line, allowing aspiring coaches access to the accreditation process at their own convenience.

SDPO is now able to assess Recognised Prior Learning requests for Level 1 Accreditation.

Level 2 Coach Accreditation transition to an on-line system is still in development by Rowing Australia although expected to be available mid-year. We are now considering, if demand warrants, another Tasmanian Intermediate Level 2 Coaching Course, similar to the course conducted at Lake Barrington in 2017.

Tasmania currently has 84 Nationally Accredited Coaches, with a further 16 pending Level 2 completion.

We understand Rowing Australia is also currently investigating development of a National Accreditation scheme for Boat Race Officials.

In conclusion, I would like to sincerely thank the Tasmanian rowing community and Board of Rowing Tasmania for your ongoing support.

The Tasmanian State Championships saw the newest rower Michael Taylor take out the title in the LTA 500m sprint, with Sara Waitzer taking out the Women's 1000m Championship, and Alistair Chong taking out the men's.

The turnout of Tasmanian athletes to the National Championships was amazing and had a great impact on other rowing states, and we were able to really show our true colours. The Tasmanian flag was flown in the PR3 (LTA) mixed double, with Alistair and Sara taking out bronze. The first Tasmanian led para coxed four was also a sight to see, with athletes Alistair, Sara and Michael joining forces with Ruby from Balmain Rowing Club in Sydney to gain a bronze.

This year was also the first time that para-rowing was introduced into the Australian Masters Championships which were fortunately held at Barrington. This year's race included both Alistair and Michael from Tasmania, as well as Kevin Wall from Western Australia. The race saw joint Gold medals awarded to Alistair and Kevin, and a Silver medal awarded to Michael.

We look forward to the upcoming season and hope that a wholly Tasmanian four can be present and trained to compete at the Australian National Championships in 2019.

## **Tasmanian Masters Commission Report.**

AUSTRALIAN NATIONALS MASTERS REGATTA. (Reproduced and amended from correspondence to the Rowing Tasmania President in May)

### **THE LAYOUT OF THE BOAT-PARK.**

The way this worked cannot be faulted, and comment from local rowers and interstate visitors alike was overwhelmingly positive. The new racks we already knew to be excellent, and the availability of clubs to have their trailers nearby to allow safe boat storage was very successful.

No one was significantly inconvenienced by the exclusion of cars from the road. Although the rain made parking a bit "interesting" for some drivers at times, overall this worked well.

The tent-park received highly favourable comment, to the extent the RT might consider making it a permanent feature. The commercial tenting was similarly excellent.

No other venue in Australia would permit such a convenient and safe arrangement.

### **THE COURSE.**

This looked great and operated perfectly. Once again, we proved we have the best, fairest and most sheltered course in Australia.

Perhaps the warm-up area and marshalling area could have been better marked. Perhaps by providing more buoys and/or signage would make it clearer when one was moving from one to the other, or which one the boat was in, at which point the anti-clockwise rule began and ended, that situation could have been improved. There was at least one "near miss".

### **THE OFFICIALS.**

Tasmanian and interstate officials alike were polite, clear and firm. Just what you want from them. All who heard it loved the "Are you ready, sir" from the starter to the 92 year old sculler in the ML1X. One should live so long!

### **THE VOLUNTEERS.**

We could have done with a few more. (Our president was seen running around day after day like the proverbial "blue-arsed fly", making sure all the T's were crossed) But they were great. I heard favourable comment, for example, about how well the secretary's office ran, and where had the queues for the issue of numbers gone, by favourable comparison with certain regattas interstate?

Results were posted very quickly.

### **THE CATERING.**

This was terrific. There was nothing but favourable comment about the food, and the service in the Reeconian's Centre.

There was a problem with the meal on Saturday night. This was served late, and there were some athletes who had paid, deciding to leave to travel to Sheffield to eat there, instead. The food was satisfactory, when it arrived.

### **RUBBISH COLLECTION AND LAVATORY CLEANING.**

Faultless.

### **SUMMARY.**

RT has always run excellent major events, and this was no exception. This time, it set a new standard for others to attempt to emulate.

### **REPRESENTATIVE CREWS and CLUB CREWS.**

Tasmania was represented in the Women's Eight, Women's Quad and Men's quad. I will not name those selected. All crews were required to trial, in order to show they were capable of achieving a race-time which if recorded in the event could result in winning a medal, or at least put them in a competitive position. I believe the

aims were achieved. The Men's Quad came third, only 6.57 seconds behind the winners. Its trial time had been faster than its race time was.

The Women's Quad came 5<sup>th</sup>, beating NSW and recording a time only 9 seconds behind the winner. Its race time was slower than its trial time.

The Women's Eight was 5<sup>th</sup>. The crew had experienced a somewhat disrupted preparation, and may have been disadvantaged by a perception that some of those selected could not adapt to rowing on their unflavored side of the boat. Nevertheless, their coach, Ron Wood (whom I thank for doing a great job uniting the crew and preparing them to best advantage) succeeded in moulding them into a competent crew, which achieved the selectors' aim described above.

I thank the selectors: Chris Symons, Jason Dolbel and John Bannon. Their role can be a thankless one, as we know, but they approached it enthusiastically and competently. I hope they will be prepared to repeat the experience next year.

I thank the rowers and scullers and their coaches for representing Tasmania with courage and honour.

There were some fine results recorded by Tasmanian rowers and scullers, too many to be mentioned here. One, however, stood out. This was the Men's C Eight, which won the event in a time of 3:01.43, beating the Queensland crew, which was very similar to the Queensland Interstate Eight (rowing in club colours of course) by over two seconds. Queensland had won the IS8+. Congratulations, gentlemen.

The Master's Commission annual meeting is to be scheduled to be held at the Man O'Ross Hotel on 9<sup>th</sup> September. It has been delayed because of my absence during Late July and until mid-August.

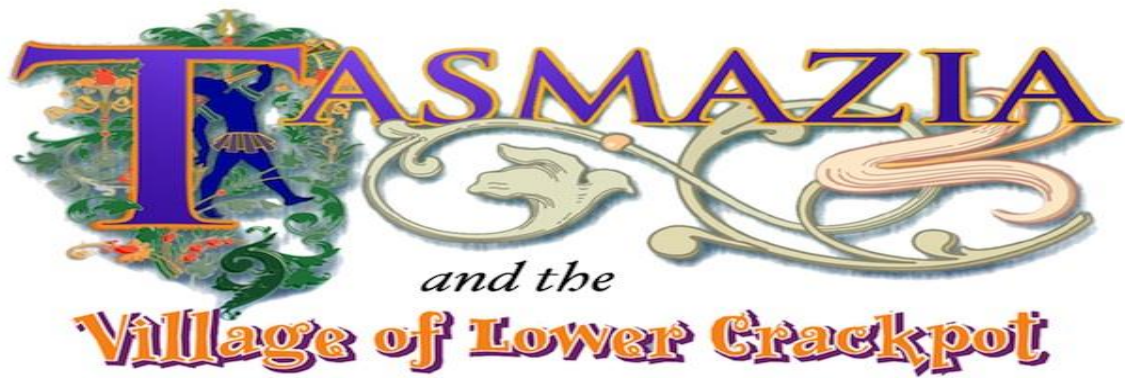
