4-CHAIRMAN of the BOARD REPORT.

I have pleasure in presenting the Chairman's report for 2020, the 108th Annual General Meeting.

The season once again commenced on a very successful note and we were heading towards record numbers of entries across our Club and School competition.

I would like to start by thanking my Board who has been operating under the new Constitution. They have been very busy with the development of the Governance of our sport and adapting to the ongoing changes. We have been formalising the new Commissions that will operate under the Board and hopefully in the coming season we will see people volunteer for positions as they are called for.

During the season Rowing Tasmania took over the operations of the Tasmanian School Rowing Association and their accumulated funds were transferred across to RT. I would like to thank all those who have fulfilled positions with the TSRA over many years and we look forward to working with the new Schools Commission in the coming season.

We also saw the establishment of the Audit & Risk Committee which has already successfully operated during the season and has assisted the Board in the many facets of the financial operations of RT. The three members have shared the roles in relation to the preparation of financial statements, budgeting, and future financial structures and procedures.

Rowing Tasmania in conjunction with Kentish Council was successful in obtaining a Federal grant under the Community Development Grants Program of \$750,000 for upgrades to our facilities at Lake Barrington. Most major facilities at Lake Barrington have been in operation for over 30 years and were in need of major development. I would like to thank the Federal Government for making funds available so that we can improve our facilities, which was well outside our financial capabilities.

This project is well underway, which will see the refurbishment of Davies Bay Lodge, Finishing Tower, and replacement of seating and bollards around the regatta grounds.

The rotunda is being replaced, a new shower and toilet block provided in the camping ground, and the redevelopment of the Sam Le Compte building into a museum and coffee lounge. In addition to this, a new storage shed will be built to accommodate our ever-growing fleet of motorboats and equipment.

I would like to take the opportunity to thank The Hub, a Sheffield Group of volunteers who have provided funds for the new electric barbecues in the rotunda. Also thank you to Kentish Council and Parks and Wildlife Service and their staff for their continued assistance in this project.

During the season Rowing Australia announced its successful negotiations with the Tasmanian Government in receiving funding to conduct a King's Cup and Australian Championships and two Australian Masters Championships at Lake Barrington over the coming eight years. This was a tremendous achievement and I thank the Tasmanian Government for taking the initiative to be part of this new approach of conducting these events around the Australian States once again.

Unfortunately, as you are all aware our rowing community was dramatically affected by COVID-19, as was every part of our daily lives, both here and across Australia. The Australian Masters' Championships which were to be held at Lake Barrington in April 2020 were cancelled and we are currently in limbo in relation to what will happen to the Australian Rowing Championships in March 2021.

Rowing Australia has confirmed that we have now been allocated the Australian Masters Championships in 2024 as well as 2028, which was already allocated.

Tasmania was lucky in the fact that we conduct our regattas from October to April so we were able to run most of our Club events, excluding some Masters events. Unfortunately, we were only partway into our School program and one of the hardest decisions made was to cancel all remaining School events for the season. It was disappointing that our new junior school rowers missed out on the opportunity to compete and our seniors' did not have the opportunity to finish their school rowing careers on a high.

COVID-19 has affected all aspects of our life, including the activities of our rowing community. It has been a very demanding time for all those involved, especially when we have to close down all our School and Club rowing facilities. The Board of Rowing Tasmania has taken all steps to keep our community informed of restrictions and our slow return to rowing. This was made possible by the extensive work done by Rob Prescott. The tremendous involvement in the indoor rowing competitions can be attributed to the hard work done by Grant Pryor and his small team.

The Board has held regular Zoom meetings with Presidents and School Rowing Directors to keep them abreast of the ever-changing environment in which we are operating. I would like to thank all Clubs and Schools for their contribution to making sure that our sport operates within COVID-19 restrictions. We will continue to communicate with our members in what will be a difficult season, working within the restricted numbers, social distancing, and personal hygiene for the coming season.

I would like to take this opportunity to thank the organisations that we have worked with during the year, being Rowing Australia, Department of Community Sport and Recreation, Tasmanian Institute of Sport, Marine and Safety Tasmania, Hydro Tasmania, Kentish Council, and Parks and Wildlife Service.

Once again, the State Government has supported our sport with our annual grant plus an additional grant from the COVID-19 support package and the waiver of our three-month Hydro account. We have also been able to access funding under the Federal Government COVID-19 schemes, and without this assistance, our financial situation would have been much worse than it currently is.

As previously mentioned, with the cancellation of the School and Masters regattas and the Australian Masters' Championships our anticipated cash flow was greatly reduced, which reflected in our overall final reserves at the end of the season.

The sport of rowing in Tasmania would not be in the strong position it is in if not for all our volunteers and staff who contribute numerous hours to our sport. Thank you very much for your passion for our sport; it would not be what it is without all your combined efforts. Every member is important to the sport, whether your contribution is at school, club, and state level, rower, coach administrator, volunteer, or staff.

Stay Safe and enjoy the coming season no matter what format it may take in these changing times.

ROWING TASMANIA INCORPORATED NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED JUNE 30 2020

STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES.

(a) Basis of Preparation

These financial statements are a special purpose financial report prepared in order to satisfy the accounts preparation requirements of the Associations Incorporation Act (Tas) 1964. The Committee has determined that Rowing Tasmania Inc is not a reporting entity,

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets. No regard has been paid to Accounting Standards and other professional reporting requirements (Urgent Issues Group Consensus Views) in the preparation and presentation of these financial statements.

(b) Income Tax

The Association's income is exempt from income tax pursuant of Section 50-45 of the Income Tax Assessment Act 1997. All figures recorded in the Financial Statements are net of Goods & Services Tax (GST).

(c) Revenue and Other Income

Government grants are recognised when the Association obtains control over the funds, which is generally at the time of receipt.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument.

All other revenue streams are measured at the fair value of the consideration received or receivable after taking into account any discounts and volume rebates allowed.

(d) Goods and Services Tax (GST)

Revenues, expenses, and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense. Receivables and payables in the Statement of Financial Position are shown inclusive of GST.

(e) Property, Plant, and Equipment

Property, plant, and equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all property, plant, and equipment is depreciated over the useful lives of the assets to the Association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the estimated useful lives of the improvements.

Items of property, plant, and equipment purchased for less than \$500 are not depreciated and are expensed in the year of purchase.

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D) (f)

Employee Benefits

Wages & Salaries and Annual Leave

Liabilities for wages & salaries, including non-monetary benefits, and annual leave expected to be settled within 12 months of the reporting date are recognised in current liabilities in respect of employee's services up to the reporting date and are measured at the amounts expected to be paid when the liabilities are settled.

Long Service Leave

The liability for long service leave is recognised in current (where applicable) and non-current liabilities, depending on the unconditional right to defer settlement of the liability for at least 12 months after the reporting date. Long service leave is only recognised in the financial statements for employees with 7 or more years of service. Non-current liabilities are discounted based on the probability of employees qualifying.

Defined Contribution Superannuation Expense

Contributions to defined contribution superannuation plans are expensed in the period in which they are incurred.

3. PROPERTY, PLANT & EQUIPMENT (CONT'D)

In November 2005, the Department of Tourism Parks Heritage and the Arts ("the Crown") gifted to Rowing Tasmania Inc by deed, various assets within the complex known as the outdoor pursuit Centre at Lake Barrington for anominal consideration of one dollar. These assets include non-fixed assets kept in the pursuit centre, rangers' cabin and facilities building together with the water infrastructure of the rowing course.

The committee has not assessed the fair value of these assets due to the difficulty in obtaining a reliable method of valuation. In the committee's opinion, the fair value of this equipment on an alternative use basis would be minimal due to the specific nature of the equipment and the cost of dismantling and relocation. Accordingly, the fair value of these assets is not reflected in the Balance Sheet of the Association and the value of the gift from the Crown has not been included in the retained earnings of the Association.

In March 2020, Rowing Tasmania Inc was approved funding of up to \$750k (GST exclusive) under the Community Development Grants (CDG) program for the Lake Barrington Precinct Project. The first progress payment is due on 12'^ August 2020, upon successful completion of Milestone information by the end of July 2020. Costs incurred to date under the project have been capitalised as Works in Progress. Grant income has not been accrued on the basis that Rowing Tasmania Inc. does not obtain control of the funds until the milestone reporting has been completed.

Report on the Audit of the Financial Report

I have audited the accompanying financial report, being a special purpose financial report, of Rowing Tasmania Incorporated, which comprises the balance sheet as at 30 June 2020, the income and expenditure statement for the year then ended, notes to and forming part of the accounts, and the statement on behalf of the Committee.

In my opinion, the accompanying financial report of the entity for the year ended 30 June 2020 is prepared, in all material respects, in accordance with the accounting policies disclosed at Note 1 to the financial statements.

I conducted my audit in accordance with Australian Auditing Standards. My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of my report. I am independent of the entity in accordance with the auditor independence requirements of the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 *Code of Ethics for Professional Accountants* (the Code) that are relevant to my audit of the financial report in Australia. I have also fulfilled my other ethical responsibilities in accordance with the Code.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my opinion.

Emphasis of Matter — Basis of Accounting

I draw attention to Note 1 to the financial statements, which describes the basis of accounting. The financial report is prepared to assist the entity for the purpose of fulfilling the Committee's reporting requirements under the *Associations Incorporation Act (Tae) 1964.* As a result, the financial report may not be suitable for another purpose. My report is intended solely for the entity and should not be distributed to, or be used by, parties other than the entity. My opinion is not modified in respect of this matter.

The responsible entities of the entity are responsible for the preparation and fair presentation of the financial report in accordance with the basis of preparation disclosed at Note 1 to the financial statements and for such internal control as the responsible entities determine is necessary to enable the preparation of the financial report that is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the responsible entities are responsible for assessing the entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the responsible entities either intend to liquidate the entity or to cease operations, or have no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the entity's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Report

- Identify and assess risks of material misstatement of the financial report, whether due to
 fraud or error, design and perform audit procedures responsive to those risks, and obtain
 audit evidence that is sufficient and appropriate to provide a basis for my opinion. The risk
 of not detecting a material misstatement resulting from fraud is higher than for one
 resulting from error, as fraud may involve collusion, forgery, intentional omissions,
 misrepresentations, or the override of internal control;
- Obtain an understanding of internal control relevant to the audit in order to design audit
 procedures that are appropriate in the circumstances, but not for the purpose of expressing
 an opinion on the effectiveness of the Entity's internal control;
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the responsible entities;
- Conclude on the appropriateness of the responsible entities' use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Entity's ability to continue as a going concern. If I conclude that a material uncertainty exists, I am required to draw attention in my auditor's report to the related disclosures in the financial report or, if such disclosures are inadequate, to modify my opinion. My conclusions are based on the audit evidence obtained up to the date of my auditor's report. However, future events or conditions may cause the Entity to cease to continue as a going concern;

Evaluate the overall presentation, structure, and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.

I communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that I identify during my audit.

6-Executive Officer's Report.

This past year has presented us with many highlights and several challenges with the most significant challenge being COVID-19, the positives have been how our rowing community responded to the pandemic by embracing the requirements that have been asked of the Tasmanian Community by our governments, both State and Federal with a common desire to abide by any requirements with the outcomes of community safety and being able to return to being on the water, and I thank the clubs, coaches, committees, and athletes for their actions and support.

With this in mind, I would like to also thank Communities Sport and Recreation, Rowing Australia, Sport Australia, Clubs Tasmania for the support that has been given, and offered as we respond to COVID-19.

Secondly, I would like to thank my fellow CEO's and Executive Officers from the State and Territory jurisdictions who have shared many documents, policies, and conversations on this subject.

I would also like to thank Mick Casey, his advice and counsel in all things COVID has proven to be invaluable.

The highlights, of this year, include.

Membership numbers for both Clubs and Schools have increased from the previous year.

Regatta seat numbers were on track to exceeded the previous season but remain nearly the same as we lost our Tasmanian Masters event and the Tasmanian Schools Championships.

The **New faces** in our volunteer rank both on and off the water.

The transition of school rowers into our clubs, Grant's efforts in this area through the Pathway Eights, the School's Draft, and working with all sectors have seen our transition numbers continue to increase.

Coach Accreditation numbers continue to increase with both the Level 1 and Level 2 courses being online, in July we held a workshop for nine coaches who, after completing the online course component, spent a day working through several tasks and all were signed of as accredited Level 2 Coaches at the end of the day.

With **school rowing** now totally in house, this sector of our sport will continue to prosper with both the individual school programs and our clubs working with non-traditional rowing programs.

The **National Training Centre** relocation to Tasmania in January was an absolute bonus to us with 70 athletes, Coaches and support personal living and training at both Lake Barrington and on the Tamar River. The interaction that the athletes and coaches had with all sectors of our sport was invaluable and to see our national team members competing with both club and school rowers could well be a once in a lifetime experience, the invitation is always open for a return visit, by the way, **Rowing Australia**. Thank you to the clubs and schools who assisted the NTC relocation in many ways on such short notice.

Lake Barrington International Rowing Course continues to progress with the completion of the boat rack project and as mentioned by the Chair the **Community Development Grant** funding from the **Commonwealth Government** project is on track to be completed earlier than anticipated and the rowing and general community will benefit from the improved facilities at the complex.

Membership.

Our membership data comes from two sources, firstly Revolutionise Sport which holds the **complete** numbers of each Club and School and then Rowing Manager which holds the **competitive** membership including Coaches, Masters, Pennant, and School rowers.

The Regatta Management database - rp7 - continues to be an extremely efficient regatta organiser which enables all the paperwork to be achieved efficiently and quickly.

Finally, thanks again to the many hours provided by the on-water Boat Officials and drivers, Judges at the finish and Referees, and to those who helped in the office when needed. The time provided by all the volunteers helps the Regattas to run as smoothly as they do. A regatta would simply not happen without the support and generous offer of time from these people. It would be extremely beneficial if interested persons saw fit to train up and become on-water officials. Some regattas had to run on longer time gaps between races due to the low numbers of available on-water officials.

Tas Uni took a tight grip on the Pennant and Hydro Cup early in the season and maintained their control; right to the end, the Schools Cup was a more evenly contested competition. No school attended all the regattas which resulted in the lead changing many times. It was also good to see St Virgil's, St Marys, and GYC attending pennant regattas.

8-State Development and Pathway Officers Report.

State Pathway Program

a) Development – includes working with clubs & schools to bring students into club-based programs and assist with daily training environment.

Schools' Draft - This year, in a pilot trial to assist Member Clubs recruit more youth, we introduced a "School Leavers Draft" after having identified and profiled Year 12 rowing students. Clubs were provided an opportunity to contact the school rowers and make representations to join their club. Whilst club registrations for the coming season are at an early stage, preliminary indications are that we may be looking at a school rower to club rower transition rate as high as 40%. (Historically around 25%). There were some 53 school leavers identified for the Draft, 20 from the North/North West, and 33 from the Southern region.

Junior Pathway Development Tour — a Tri-State Development Camp with WA, SA & Tas participating was

Junior Pathway Development Tour – a Tri-State Development Camp with WA, SA & Tas participating was initiated in 2019 and successfully conducted at Champion Lakes in WA.

The tour was the forerunner of a proposed annual tristate Pathway Development Camp series for year 11 rowers, rotating between WA, TAS & SA in July School Holidays each year. Both WA & SA requested Tasmania host the event at Lake Barrington in 2020, but unfortunately, COVID-19 forced the cancellation of the event this year.

Schools' Pathway Camp - camps for those athletes who are eligible U19s in 2020, were conducted over two days during Term 3 holiday break, October 5th & 6th 2019, plus January 30th & 31st 2020 prior to SP6. Invitations to October camp were extended to some 60 year 11 & 12 athletes and coxswains then reduced to 40 athletes and coxswains for Camp #2 in January 2020.

The camps were an initiative to encourage more of our top U19 School Rowers to consider participating in the Interstate School's Pathway Eights event. The two camps were again highly successful, resulting in squad selection of four (4) School eights to represent Tasmania at the Interstate School's Pathway 8+ Regatta proposed for April 2020. Unfortunately, the Schools' Pathway Eights and National Underage Selection Regatta did not progress this year due to concerns regarding COVID-19.

b) Performance – includes identification of athlete potential, preparation of Tasmanian athlete ranking data, and assistance for athletes to progress to the TIS Emerging Talent Squad & NTC Development Squad. We are seeking athletes who continue to demonstrate the desire and training commitment necessary to achieve high-performance rowing outcomes. In preparing recommendations, consideration is given to RT Sports Science test results, regular 30-minute IPM ergometer data, 2K ergometer test results, and assessment of performance at Regattas, Time Trials, and Camps.

The following athletes were participants in TIS/RT high-performance programs this year.

NTC Athletes - Currently three Tasmanian Elite Athletes, Sarah Hawe, Ciona Wilson & Georgia Nesbitt are based full-time at the National Training Centre in Penrith, striving for inclusion in Australian Teams to contest World Championships and Olympic Games.

NTC Development Squad - Alexandra Wrigley, Jack Barrett, Joseph Wilson, Connor Ryan, Lucas Wigston, Eve Mure, Eleni Kalimnios, Wilson Mure & Alec Paterson.

Emerging Talent Squad - Sarah Ashlin, Hannah Tippett, Kate Hall, Henry Youl, Tyler Mason, Luke Haas & Finnian Colley.

Pathway Performance Camps & State Team Camps.

In conjunction with our TIS Pathway Partners, RT conducted the fourth successful TIS Pathway Performance Camp of the pre-season in September 2019. In seeking to improve our national representation numbers & national championship competition results, select invitations were extended to TIS supported athletes and athletes from the School's Pathway Eights.

State Team Camp was conducted at Lake Barrington on January 4th & 5th 2020 with 62 attendees. Athletes who were part of our 2019 State Team were extended invitations together with the top-ranked athletes from the season to date.

We would like to extend our appreciation to Member Clubs that loaned equipment and to coaches, chaperones, and helpers who availed their valuable time to make the camps successful. Kristy Paynter (ABC Catering) continued to provide exceptional meals and service at our Pathway Camps.

Tasmanian Interstate Regatta Team – after a rigorous selection process Rowing Tasmania Board accepted recommendations of our State Selectors and endorsed the selection of a team of crews, scullers, coxswains, and coaches to represent Tasmania in the Interstate Regatta at Sydney International Rowing Centre, Penrith NSW, scheduled for Sunday 29th March 2020. Due to athlete retirements, numbers of available athletes were insufficient to select a representative King's Cup crew and a Women's Para PR3 Scull representative. Unfortunately, medical concerns regarding the COVID-19 Pandemic forced the cancellation of both the National Championship Regatta & Interstate Regatta.

Rowing Australia Level 2 Coach Accreditation on-line system is now also available and is supplemented by a one day, Level 2 workshop facilitated by Rowing Tasmania.

Rowing Tasmania conducted the first Level 2 NRCAS workshop at New Town Bay Rowing Centre on 11th July 2020.

The commission responded to several of the RT Board's requests during the year. These included the selection criteria and nomination process for State master's representatives, the terms of reference for the master's commission, a different approach to selection in a year where nominations for state representation were low in rower numbers and feedback on the 2019/20 rowing year.

It is fair to say that the views/input from the Master's Commission and the RT Board deliberations varied on the selection criteria and nomination process. The feedback on the 2019/20 year was constructive and mostly practical in nature. i.e. having more than six competitors in a race at Franklin is something the commission would prefer didn't occur.

The commission has been asked to review the race program for the Tasmanian Master's Championships and this work will pass to the new commission.

I'd like to thank all the commissioners for their input and support during this COVID affected rowing year and wish the next commission the best for 2020/21.
