4-CHAIRMAN of the BOARDS' REPORT.

I have pleasure in presenting the Chairman's report for 2021, the 109th Annual General Meeting.

I was proud to be a member of the Australian rowing community on that Wednesday morning of the 2020 Tokyo Olympics when our rowers won two gold and two bronze. Definitely one of the best moments in rowing for Australia, congratulations to our rowers, not only in these crews, but to the whole representative team. Congratulations to Sarah Hawe from the Huon Rowing Club who rowed in the women's eight and to Ciona Wilson from the Tamar Rowing Club who was selected as a travelling reserve.

Bring on 2032 and the Olympics in Brisbane Australia! This presents great opportunity for our young rowers to compete at home for Australia. We have a very large group in our Pathway Program at the moment and some of these could be our representatives in Brisbane.

Congratulations to all our own rowers who competed at our home regattas, Australian Championships and Australian Masters Championship. Their achievements and highlights are detailed in other sections of the Annual Report.

At this time last year, we were living with the uncertainty of what our rowing season for 2021 would be like, under the restraints of Covid-19. I am happy to report that with the co-operation of the whole rowing community, we were able to conduct one of our largest competitive seasons ever held.

It was a different season with the restraints put on us because of Covid-19, for example, limited numbers, check in at events, no camping, social distancing and all the extra work that came with these new rules.

Unfortunately, as I write this report Covid-19 is still very much with us and we have been advised that the coming season will most likely look no different than the one we have just completed. I am sure that with the co-operation of all our Clubs and Schools we will once again be able to hold a successful season and stay safe at the same time.

The last twelve months have definitely been one of the busiest for all those involved in rowing, and I would like to take this opportunity to thank the Board and all our rowing volunteers who have contributed to our success.

As mentioned in my last report, the Federal Grant under the Community Development Fund Program of \$750,000 has allowed us to upgrade our facilities at Lake Barrington. In June of this year Senator Claire Chandler officially opened these upgraded and new facilities. In her speech she commented on the extent of the improvement of the facilities for the money that we received. This was achievable only because Mick Goodger took over the Management of the project and a hands-on role. In recognition of Mick's contribution to this project and all those preceding projects the Board has unanimously agreed to name the new storage shed "The Michael Goodger (Mick) Shed". This was formally announced by Senator Chandler at the opening and an official unveiling will be held during a regatta so that we all will have an opportunity to thank Mick for his amazing contributions.

All the facilities provided by this grant are now finished and ready to be used for the coming season. Further improvements to Lake Barrington will take place following the promise of funding from the State Government.

It was disappointing in the previous season that we missed out on the Australian Masters Championships, but we were able to proceed with the Australian Rowing Championships King's & Queen's Cup in March 2021. Once again, due to restrictions of Covid-19 the go ahead to conduct the Championships was given at a very late date. Even though the organising group had been working on this project for the best part of twelve months, it did add new pressures at the late approval date to go ahead.

The Championships were conducted under the new model which included a working partnership of Rowing Australia, Rowing Tasmania, and the professional events company Ted&Co. I can honestly say we were a bit sceptical as Tasmania has in the past ran many successful national events. The outcome was evident from the success of the event and the experience of working with a professional event's organiser was a satisfying experience.

The organising group was made up of RA & Ted&Co staff and a small group of Tasmanian volunteers who communicated on Zoom over a six-month period and only had the opportunity to come face to face twice prior to the event. Thank you to all those who volunteered to be part of this hard-working group. If it was not for their dedication to our sport, the event would not have gone ahead. During the actual competition the number of volunteers grew enormously, and I would like to thank all those members of our community who came forward to fill those positions. Once again, so many oarsmen from around Australia got the opportunity to compete at Lake Barrington International Rowing Course. It was a pleasure to welcome old and new faces to what was described as the "Friendly Games".

Thank you to Rowing Australian for taking the initiative to approach Events Tasmania to conduct these competitions in our state. We have now been allocated the Australian Masters in 2024 to replace 2020 and again in 2028. They have also opened negotiations in regard to the 2025 Australian Rowing Championships King's & Queen's Cup.

There was a financial reward for conducting the event, being \$100,000 towards the infrastructure which was part of the deal between Rowing Australia and Events Tasmania. In addition to this, Rowing Tasmania netted approximately \$100,000 from holding the event at Lake Barrington.

The operations of Rowing Tasmania are made possible by a small number of staff, I would like to take the opportunity to thank these, especially for the amount of work that our Executive Officer Rob Prescott has put in during the season. The restraints put on us by Covid-19 definitely added to what is a very full workload. Unfortunately, at the end of the season, our State Development & Pathway Officer, Grant Pryor retired. This was a new position originally taken up by Grant, which he has developed over the years; this has been an amazing contribution to Rowing in Tasmania. His vast experiences in rowing over many years have been a great asset to our sport. We wish Grant all the best in his part retirement.

To Lisa and Cheryl, our cleaning team at Lake Barrington, thank you for your all your work over the years, both ladies have resigned.

To Denise O'Shea who has looked after our day-to-day bookkeeping and being the Minute Secretary, thank you for all your contributions in assisting Rob and the Board. Denise has informed us that due to other commitments she will be resigning from this position shortly.

With the redevelopment of the Sam Le Compte building, we have now changed our operations of catering, separating the coffee from the Easy Oar Cafe. This has proved to be a total success story. Now that the Museum is completed we hope to see this facility fully utilised in the coming season. Thank you to Carmen who has overseen these changes, managed the kiosk and took on the huge task of Manager of the Kiosk and Coffee Cafe during the Nationals.

Thank you to the Clubs and Schools who provided the volunteers for catering, who got to share in the increased profits.

We are so lucky, as a rowing community to have a course like we have at Lake Barrington. Over a number of years, the Board has carried out several projects to upgrade this facility. A special thank you to Steve May our groundsman, who assisted on the major project and maintained our grounds, which are a showcase for us and all our visitors. The endless work put in by Mick Goodger, George Homer and John Oakley, both on and off water does not go unnoticed or unappreciated.

A successful regatta season can only take place with a large number of volunteers, there is endless work that takes place behinds the scene during the week and then there are those volunteers who turn up for every weekend regatta. To the members of the BOAT Race Officials, thank you for your tireless work under the leadership of Fritz Fraser, Tina Maher, and Chris Symons.

To our two Regatta Managers, Brian Brennan, and Karen Bain, thank you for your continuous contribution to our busy regatta season.

Also, a big thank you to Peter George and his group of boat drivers.

If we are to continue to offer the standard of regattas into the future we will need more members of our rowing community to join our BRO's. Unfortunately, our group of volunteers are aging, and it is imperative that we attract younger members of our rowing community to assist in this area.

The sport of rowing in Tasmania would not be in the strong position it is in if not for all our volunteers and staff who contribute numerous hours to our sport. Thank you very much for your passion of our sport; it would not be what it is without all your combined efforts. Every member is important to the sport, whether your contribution is at school, club, and state level, rower, coach administrator, volunteer, or staff.

Stay Safe and enjoy the coming season no matter what format it may take in these changing times.

NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 30 JUNE 2021

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of Preparation

These financial statements are a special purpose financial report prepared in order to satisfy the accounts preparation requirements of the Associations Incorporation Act (Tas) 1964. The Committee have determined that Rowing Tasmania Inc is not a reporting entity,

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets. No regard has been paid to Accounting Standards and other professional reporting requirements (Urgent Issues Group Consensus Views) in the preparation and presentation of these financial statements.

(b) Income Tax

The Association's income is exempt from income tax pursuant of Section 50-45 of the Income Tax Assessment Act 1997. All figures recorded in the Financial Statements are net of Goods & Services Tax (GST).

(c) Revenue and Other Income

Government grants are recognised when the Association obtains control over the funds, which is generally at the time of receipt.

(d) Goods and Services Tax(GST)

Revenues, expenses, and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense. Receivables and payables in the Statement of Financial Position are shown inclusive of GST.

(e) Property, Plant and Equipment

Property, plant, and equipment is carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all property, plant and equipment is depreciated over the useful lives of the assets to the Association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the estimated useful lives of the improvements.

Items of property, plant and equipment purchased for less than \$500 are not depreciated and are expensed in the year of purchase.

In November 2005, the Department of Tourism Parks Heritage, and the Arts ("the Crown") gifted to Rowing Tasmania Inc by deed, various assets within the complex known as the outdoor pursuit Centre at Lake Barrington for nominal consideration of one dollar. These assets include non-fixed assets kept in the pursuit centre, rangers' cabin and facilities building together with the water infrastructure of the rowing course.

The committee has not assessed the fair value of these assets due to the difficulty in obtaining a reliable method of valuation. In the committee's opinion the fair value of this equipment on an alternative use basis would be minimal due to the specific nature of the equipment and the cost of dismantling and relocation. Accordingly, the fair value of these assets is not reflected in the Balance Sheet of the Association and the value of the gift from the Crown has not been included in the retained earnings of the Association.

In March 2020, Rowing Tasmania Inc were approved funding of up to \$750k (GST exclusive) under the Community Development Grants (CDG) program for the Lake Barrington Precinct Project. At 30 June 2021 progress payments have been received of \$562,500. The final progress invoice of \$187,500 (ex GST) was issued in June to the CDG program for payment to Rowing Tasmania Inc.

Opinion

I have audited the financial report, being a special purpose financial report, of Rowing Tasmania Incorporated, which comprises the balance sheet as of 30 June 2021, the income statement for the financial year then ended, notes to the financial statements, and the statement on behalf of the committee.

In my opinion, the financial report of Rowing Tasmania Incorporated for the financial year ended 30 June 2021 has been prepared in all material respects, in accordance with the accounting policies disclosed at Note 1 to the financial statements.

Basis for Opinion

I conducted my audit in accordance with Australian Auditing Standards. My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of my report. I am independent of the Entity in accordance with the auditor independence requirements of the ethical requirements of the Accounting Professional and Ethical Standards Board's *APES 110 Code of Ethics for Professional Accountants (including Independence Standards)* (the Code) that are relevant to my audit of the financial report in Australia. 7-Regatta's Managers Report-Club.

A fantastic season with entries high, especially in the second half of the season. Four regattas, SP3–SP4– SP6–Championships had the highest attendance for comparative regattas over recent years, probably ever. SP4 and SP6 were the highest attended regattas of any for many years. The entry total for SP6 of 2569 will take some beating. Very little racing was lost due to weather. The sport had a very successful season, which could have resulted a little from the Covid outbreak in early 2020. Many sports were interrupted, or lost completely, so it is possible that athletes in general were excited by the full and normal rowing season. Rowing may have benefited greatly from its timing within the year. It will be interesting if next season follows that trend, or changes yet again.

One issue which arose from the high entry rates was the length of the regattas. Yes the numbers were up, but the shrinking numbers of officials meant that sometimes the gaps between races had to be slightly longer than optimum. There is no doubt that there is a need to "attract" more helpers to optimise the timing for regattas.

The "pathway" established for rowers, namely U17-U19-U21-Senior seems to be working well. Numbers definitely increased in the U21 group. Some rearrangement of 8's races, especially for the Senior Men and Women seemed to be met with approval.

Seats per Regatta Summary

The IT environment continued to develop considerably throughout the season thanks to the indefatigable efforts of Fred Slamen who continued to make it a personal project. The transfer of results from the Finish tower to the Office became significantly more reliable. With the spectre of National Championships on the horizon the results system worked perfectly.

The continued support of the Ulverstone Scouting group in manning and womaning the boat-holding at the start is greatly appreciated. Rain or shine, they were there doing their bit – a great effort. The club support of the rostering of other jobs – boat driving and numbers – has also become very efficient with volunteers coming forward at all times. This is a critical task, and the regatta cannot proceed without this support. The assistance of Peter George in organising the boat driving roster is greatly appreciated.

The Regatta Management database – rp7 – continues to be an extremely efficient regatta organiser which enables all the paperwork to be achieved efficiently and quickly. Regatta Manager has developed a basic regatta "score" for rating rowers, but it is still slightly short of the mark as it takes each race as self-standing. This fails to account for weather variations. I still hope this can be addressed in the future.

Finally, thanks again to the many hours provided by the on-water Boat Officials and Referees and to the many people giving time to help in the Office. The time provided by all the volunteers helps the Regattas run as smoothly as they do. A regatta would simply not happen without the support and generous offer of time from these people. In addition, as all our regattas are now managed by Rowing Manager and rp7, a number of other volunteers have up skilled in the office so that they are available for other non-pennant regattas such as Schools regattas and Masters regattas.

Tas Unitook atight grip on the Pennant early in the season, though Bucks kept the pressure on for the Hydro Cup right to the end. A great showing by New Norfolk and Mersey clubs who both had good overall seasons. Grammar sowed the way in the Schools Cup, closely followed by Scotch.

Bad weather did result in a number of events being curtailed, and with senior events limited and the program shortened.

The significant increase in competitors and seat numbers did result in long sessions, particularly for Schools Regatta Two and the Saturday heats at the Schools' Championship Regatta. As with the Club Pennant series, this again put considerable strain on Boat Race Officials.

9-Tasmanian Schools Commission Report.

The Schools Commission first met in July 2020. Members are Tom Allwright, Karen Bain, Mick Casey, Nathan Dolbel, Adam Forsyth, Julian Joscelyne, Graham Scattergood, and Ollie Wilson-Haffenden. Rob Prescott participates ex-officio. The Commission has met on five subsequent occasions.

Matters addressed by the Commission include two brought forward by school Directors of Rowing, which the Commission support:

- The School Regatta Calendar proposals include the introduction of two junior sprint regattas and an additional 2-day regatta at LBIRC in term 4 to replace the Southern Junior Sculling Regatta; and
- **Regatta events and program** revision of the 2-day program so that junior girls and boys have their three rows on the one day, and revision of the program to facilitate a better flow of events.

The Commission is also progressing the following:

- Schools Championship format considering moving to the same format as other two-day regattas, with the Division 1 event being the championship event;
- School Regatta Rules work is progressing, in consultation with the RTRules Committee, on better incorporating school rowing into the RT Racing Code;
- Seeding of rowers and crews pursuing options to better seed events using Rowing Manager;
- **Rower registration**-progressing transition to on-line registration as is currently done for club rowers; and
- **Recruitment of additional Boat Race Officials for school regattas** recognising that additional regattas will require schools and clubs to provide supporting officials as with most other school sports.

With this substantive work program to carry through, we have has set a monthly meeting schedule leading into the 2021-22 season.

All these require consultation and coordination with others – thanks to Karen for consulting with the RT Regatta Review Working Group and Rowing Manager software developer/manager; to Ollie and Tom for consulting with Directors of school-run rowing programs; and to Rob for maintaining the communication lines with the Board as well as facilitating our virtual meetings.

10-Tasmanian Masters Commission Report

As with all participants in our sport, the commencement of the COVID pandemic impacted the Tasmanian masters rowing community in a variety of unexpected ways. 2020 saw the cancellation of both the regular master's regatta calendar and then later the Australian Masters Rowing Championships, which were due to be held at Lake Barrington that year. The season ended with a disappointing whimper with participants in many cases left to resort to Zoom erg sessions with teammates in an effort to retain fitness and lift spirits whilst in quarantine.

The 20/21 season, held under modified COVID rules, offered the renewed promise of once again returning to both the water and the sport we love, but with the greater effects of the pandemic on overall participation levels being a significant unknown. What would the hidden cost of COVID, combined with the disappointment of the previous season truly be.

As it turns out ours is a vibrant, resilient, and connected community. And although the necessary restrictions at the Lake in particular saw less overall socialising (with no beer fines being handed out on Saturday evenings for mid race collisions this year), we were able to come together as a community to participate, support and contribute to our sport in record numbers.

It is interesting to note that this year during the regular pennant season (SP1 to State Champs) 22% of seats boated were from the Masters community. If the State Masters regatta were to be included in these numbers (which saw 303 entries and 924 seats over two fun filled days) then that percentage increases to 27%. Masters rowing is a truly vibrant component of the Tasmanian rowing scene.

But for the greater rowing community as a whole ours is not just a contribution made through "bums on seats" alone. It's heartening to see the off-water contribution the master's community has made in the last twelve months to ensuring the success of our sport, be it at a squad, club, or state level. Time is a commodity that is sadly in short supply, yet it is through the often-unacknowledged sacrifices made by many in our community, be it in big or small ways, that we ensure our sport not only succeeds, but thrives. To all those people, our heartfelt thanks.

It would be remiss of any summary of the year to not finish with a celebration of our successes. And perhaps no greater evidence of success can be given than seeing two Tasmanians named the top two athletes at the recent Australian Masters Rowing Championships. Tom Wilcox and Jacqui Hope (both from the Lindisfarne Rowing Club) accumulated enough championship points to be awarded this prestigious honour. As we know both are tough competitors and exceptional athletes. To you both go our most heartfelt congratulations.

As our 20/21 season formally draws to a close, we now look forward to the 21/22 season and the associated competition, connectedness and comradery that abounds in our sport.

11-State Development and Pathway Officer Report.

State Pathway Program

Secondary School Recruiting

During the past year we have been involved with some 250 students in Sports Science Testing (NTID – National Talent Identification). The program involves Anthropometric Tests (body measurement) plus strength & endurance testing, utilising RT equipment. We have engaged with Launceston College, Prospect High School & Launceston Grammar School, Claremont High & St Virgil's College, Exeter High School & Devonport High School.

Additionally, 190 public school students participated in "Try Rowing" sessions utilising RT's fleet of Wavecutter Training Sculls and assisted by volunteer coaches from member clubs. I would like to particularly acknowledge the support of Tamar, Mersey & Buckingham Rowing Clubs in delivering this program. Sessions included specific beginner sculling skill exercises as well as fun activities on water to introduce potential new rowers to our sport.

Schools' Pathway Camp

Camps for those athletes who are eligible U19s are usually conducted over two days during Term 3 holiday break in early October annually, plus a one-day familiarisation camp in January prior to SP#6.

The camps are an initiative to encourage more of our top U19 School Rowers to consider participating as Tasmania's representatives in the Interstate School's Pathway Eights event.

State participation in the Schools' Pathway Eights Regatta has in past been limited to 2x Schoolgirl and 2x Schoolboy eights from each state, however this year due to escalating interest in the event, Rowing Australia advised we were able to select additional crews. With five selected school eights, Tasmania provided the equal highest number of entrants, matched only by the host state.

The event was initially scheduled for Sydney International Rowing Centre but was relocated to Westlakes Rowing Course in Adelaide following major flood damage to the rowing course infrastructure in Penrith.

Unfortunately, the South Australian event was subsequently also cancelled due to Covid-19 interstate travel restrictions.

In order to provide a competition for our Tasmanian contingent who had maintained diligent training regimes despite the setbacks, a "Schools' Pathway Eights Simulation Regatta" was conducted at Lake Barrington in April, with our five representative eights competing against crews comprised of TIS athletes and Australian Underage Team members from Tasmania.

Coach Education

Rowing Tasmania plans & coordinates coaching seminars and facilitates the Rowing Australia National Rowing Coaching Accreditation Scheme in Tasmania. There are currently 91 Nationally Accredited Coaches in Tasmania.

Rowing Australia Level 1 Coach Accreditation is now available on-line, allowing aspiring coaches access to the accreditation process at their own convenience. Tasmania currently has fifty-one (51) Level 1, National Coach Accreditation Scheme (NCAS) approved coaches.

Rowing Australia Level 2 Coach Accreditation on-line system is now also available and is supplemented by a one day, Level 2 workshop facilitated by Rowing Tasmania. Tasmania currently has thirty-six (36) Level 2, National Coach Accreditation Scheme (NCAS) approved coaches.

Rowing Tasmania conducted two Level 2 workshops during the past 12 months.

Additionally, we have three (3) Level 3 coaches and one (1) Level 4 coach in Tasmania.

I believe our coaches in Tasmania are the most **under-valued** assets in our sport. An incredible amount of their personal time is spent year-round, planning rowing programs, attending training sessions (often twice daily), regatta attendance and equipment transport, whilst maintaining regular full-time employment as well.

It is time we found an appropriate method of recognising & rewarding their volunteer efforts.

In conclusion, I would like to sincerely thank Jim Gibson, the Rowing Tasmania Board, and members of the Tasmanian rowing community generally, for your valued support during my tenure with both Rowing Australia (2012–2016) and Rowing Tasmania (2017–2021).
